- 1. Reynolds Toney determined that a quorum was present and called the meeting to order.
- 2. Robert Burton moved to approve the minutes of the April, 2006 meeting. Seconded by Rod Abbott. Approved unanimously.
- 3. The Chair introduced the new members of the Board: Craig Parker, Shawn Davis, Karl Sirmons, and John Privrat.
- 4. The Program Director:
 - a. Delivered the annual financial report.
 - b. Reviewed the FY '06 schedule and its location on the web site.
 - c. Reviewed changes to the instructor/evaluator contracts which resulted in a modest

- increase in the cost of delivering the modules. Payment would be based on a percentage of the revenue generated for certification modules and on a flat fee for training modules.
- d. Reported that Larry Patrick would no longer be working in the program but would be replaced by Steve Cross from OSU for training modules only.
- e. Reported that the investigation into the formal complaint against a RHCMT had been terminated because the consensus of the experts consulted was that, due to the nature of the tests involved in the allegations, there was no credible way to produce physical evidence that would either support or refute the allegation.
- 5. Steve Sawyer informed the Board that some modules were running long due to the added requirement to calibrate the Air Pots. The Board discussed the issue and recommended that the calibration certification procedure be abbreviated and that technicians would be given the option to certify in either T-152 (Air Pot) or T-196 (Rollameter) or both, depending upon which method they actually use.
- 6. The Chair skipped to agenda item #7, setting meeting dates for CY 2006. Dates are:

All meetings to begin at 9:00 AM.

- 7. Bill Gamel provided the Board with the option to stagger the member terms. The Board decided to leave the terms as they are. There was a discussion about what statute changes might be necessary if the Board decided to certify Construction Inspectors. It was decided that it was an issue that could be dealt with when and if the FHWA required such certification.
